**ORDER**

**THIS DAY** came the Town Council of Irvington, Virginia (the "**Council**"), by counsel, and petitioned this Court to order a special election to permanently fill the Council seat which will become vacant, effective April 1, 2022.

**IT APPEARING TO THE COURT** that the elected Town Council of Irvington, Virginia member has announced his resignation, effective April 1, 2022; that a vacancy will occur in the office of Town Council of Irvington, Virginia, effective April 1, 2022; that the Town Council plans to fill the seat temporarily until the special election can be held; that the Town Council of Irvington, Virginia, has petitioned the Court pursuant to Va. Code § 24.2-228.1 to enter an order requiring County election officials to conduct a special election on November 8, 2022 to permanently fill such vacancy; that the Council unanimously adopted a Motion on March 10, 2022 in support of said petition; that the Council properly asks that the special election should be held occurring on November 8, 2022, pursuant to Va. Code § 24.2-226.

**UPON CONSIDERATION THEREOF**, it is hereby **ORDERED** and **DECREED** that the Petition be **GRANTED** and a special election to fill the office of Town Council of Irvington, Virginia member **SHALL** be held at a special election on November 8, 2022, pursuant to the provisions of Virginia Code §§ 24.2-226, 24.2-228.1, and 24.2-681.

The Clerk of this Court is directed to send a certified copy of this Order forthwith to the State Board of Elections, pursuant to Va. Code § 24.2-684, to the Registrar for the County of Lancaster, Virginia, and to counsel for Town Council of Irvington, Virginia below.
