INSTRUCTIONS

1. RETURNS ARE DUE THE 20TH DAY OF EACH MONTH
2. LINE 5: IF THE RETURN IS FILED AFTER THE DUE DATE (20TH OF THE MONTH), THEN A PENALTY OF 5% OF THE TAX LIABILITY (LINE 3) WILL BE ASSESSED.
3. LINE 6: AN ADDITIONAL 5% PENALTY OF THE TAX LIABILITY IS IMPOSED FOR EVERY SUBSEQUENT 30 DAYS THE RETURN IS NOT FILED. THE MAXIMUM ASSESSED PENALTY SHALL BE 25% OF THE TAX LIABILITY (LINE 3).
4. LINE 7: INTEREST WILL BE ASSESSED AT 8% PER ANNUM WHICH SHALL BE COMPUTED UPON THE TAXES AND PENALTY FROM THE DATE SUCH TAXES ARE DUE AND PAYABLE.
